

# LMCU Twitter Follow Contest Official Rules

**1. ELIGIBILITY:** Must be 18 years of age or older as of the date of entry and a legal resident of Michigan or Florida. NO PURCHASE NECESSARY. Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited. Contest is not open to employees of Lake Michigan Credit Union ("LMCU") or their immediate family members, or to employees or immediate family of any of LMCU's affiliated companies, licensees, advertising or promotional agencies.

**2. CONTEST PERIOD:** Contest runs now through 11:59 PM EDT on Monday, March 28, 2022 (the "Contest Period"). Entries ([@LMCU](#) Twitter follows) must be received no later than 11:59 PM EDT Monday, March 28, 2022.

**3. HOW TO ENTER:** During the contest period follow [@LMCU](#) using your valid, active Twitter account. Limit one entry per Twitter account and per person. Any attempt to obtain more than one entry by using multiple or different Twitter accounts or any other method will void your entry. Use of Twitter is subject to Twitter's terms of service.

**4. SELECTION OF WINNERS AND PRIZE:** On or about 9:00 AM EDT Monday, March 28, 2022, Lake Michigan Credit Union (LMCU) will randomly select a) winner from all eligible entries (combined from all sources of entry), subject to verification and compliance with the rules. The winner drawn wins a \$500 gift card. Winners will be notified via Twitter private message of their Twitter user account when they entered the contest (followed [@LMCU](#) Twitter page). If an entrant selected as the winner cannot be reached within 10 days, is found to be ineligible, or otherwise fails to comply with these official rules, that entrant shall be disqualified and an alternate winner may be selected at random from among remaining entries. LMCU is not responsible for a winner's failure to answer to messages. Odds of winning depend on the number of eligible entries received and any extra entries awarded by LMCU.
